# TERMS OF SERVICE AGREEMENT

Please read the following Terms of Service Agreement ("Agreement") carefully before utilising the forgood platform ("the Platform"). Use of the Platform indicates that you ("the User") have understood and agree to be bound by the terms and conditions of this Agreement. forgood's Privacy Policy (available on <u>www.forgood.co.za</u>) is incorporated by reference into this Agreement and is subject to this Agreement. forgood may amend this Agreement at any time. All amended terms shall be effective automatically and immediately upon the posting of the revised Agreement and any subsequent activity in relation to the Platform shall be governed by such amended terms and conditions of usage.

If you do not agree to the terms of this Agreement, please do not use the Platform. If you wish to register as a User to make use of the Platform, you must read these Terms and indicate your acceptance during the registration process. Note, however, that these Terms apply to your access to and use of the Platform regardless of whether you register an account as a User.

## 1. Definitions

In this Agreement the following definitions apply:

- a. "Causes" shall mean the charities, companies, associations, non-profit organisations and schools who have registered on the Platform in order to fulfil a need by receiving a donation from a User/s or allowing a User/s to provide time or a specific skill to fulfil such need.
- a. **"Fees"** means the fees payable by you in respect of your access to the Service (including subscription fees, administrative fees as well as any VAT and other taxes, duties, levies or charges thereon that may be levied by any government authority directly or indirectly in relation to the Service).
- b. **"Need"** shall mean a request for assistance either in the form of a donation or assistance with a particular task by a User/s and/or by Causes in order to meet an immediate or going concern.
- c. **"Offer"** shall mean an advertisement offering goods, services or other relevant items from a User to a Cause/s. Both Users and Causes can create Offers on the Platform.
- a. **"Service"** for the purpose and context of Section 6 of Annexure A shall mean the forgood Premium subscription service.

- b. **"Services"** means access to the forgood Platform, online store, and donation function and premium subscription service as applicable in the context of this Policy.
- c. **"Platform"** shall mean the digital platform that provides an exchange of information in regard to social good, and connects, informs and inspires South Africans to change South Africa for good. The use of the Platform is for the benefit of the Users and the ultimate good of South Africa and is provided at no commercial cost to the Users or the Causes.
- d. **"Third Party Payment Platforms"** means external websites of payment services that facilitate online payment transactions.
- e. **"User/s"** shall mean individuals, associations, non for profit organisations and businesses who wish to donate, volunteer or become involved in the social sector and who use the Platform to register Causes or Offers for others to respond to.

### 2. Registration and Creation of an Account

- 2.1 In order to register on the Platform, you confirm that you are a natural person over the age of 18 or have the relevant consent from a parent or guardian (a Competent Person) and you duly warrant that such consent has been obtained.
- 2.2 If you are a person duly authorised to represent and register the charity, company or organisation, you hereby warrant that you are duly authorised to act on behalf of the relevant charity, company or organisation and to register the account in the name of the entity.
- 2.3 forgood is entitled to call upon you to provide documentary evidence, and/or any other information reasonably required to confirm your legal standing either as a natural person, parent or legal guardian or as a representative of a charity, company or organisation.
- 2.4 Where registration and creation of an account is undertaken by you for a charity, company or organisation, you hereby indemnify and hold forgood harmless against any and all liabilities, losses, fines, damages, expenses and legal costs ('claims") incurred (whether directly or indirectly), in the following instances:
  - a) from any cause whatsoever, including without limitation any claims arising out of or in relation to the provision of any services or information by forgood to such registered User or any third party, or
  - b) the use of the Platform by such registered User, or
  - c) any claim against forgood of any nature by the legal entity registered by such person without the relevant authorisation.
- 2.5 Registration and creation of an account requires completion of an application form including the submission of a valid email address. forgood shall utilise valid email addresses provided by you to provide updates on news, activities and topics of interest. You are entitled to notify forgood that you wish to no longer receive such communications.
- 2.6 You are responsible for providing information in the application form that is true, accurate, current and complete at all times. Information found to be false and misleading may result in the suspending or termination of the account and a refusal for all current and future use of the Platform.
- 2.7 By registering on the Platform, you agree to the following:

- a) that you will not select or use a name or e-mail address of another person with the intent to impersonate that person;
- b) use a user name or e-mail address subject to the rights of any person without authorization;
- c) use a name in violation of the intellectual property rights of any person; or
- d) use a name that forgood, in its sole discretion, deems inappropriate or offensive.
- 2.8 Upon registration of an account, you shall receive logon credentials which you undertake not to disclose to any third party so as to ensure the security of the account. Security of the account is your responsibility and forgood disclaims all liability with regard thereto. You are responsible for all activities (whether by you or by others) that occur under the account. forgood may require you to change the logon credentials at various times and you agree that you will comply with such requests. You will notify forgood immediately of any unauthorized use of the account or any other breach of security. forgood assumes no liability for any loss or damage arising from any unauthorised use of your password or account by a third party.
- 2.9 In the event of the security of an account being compromised, forgood reserves the right to suspend the processing of any communications and will immediately deactivate the User's logon credentials. You shall refrain from using the Platform until new logon credentials are issued.
- 2.10 You hereby indemnify and hold forgood, its directors, employees, agents and representatives, harmless for any and all losses, damages and expenses arising from your failure to ensure the security of the account, including all legal fees, on an attorney-client scale.
- 2.11 You agree that you shall refrain from registering and creating accounts using "bots" or other automated means.

#### 3. Permitted Use of the Services

- 3.1 Where you use the Platform to obtain information about Causes so you are able to respond by making a donation or providing a skill or time to fulfil a Need or you create or respond to an offer, you correspond directly with other User/s and Cause/s.
- 3.2 All acceptances of volunteer opportunities and any other terms and conditions that apply to such interactions, are solely between you and the User/s you choose to deal with.
- 3.3 You agree that forgood will not be responsible or liable for any loss, cost, damage, or other liability of any sort incurred as the result of any such interactions, or as the result of the presence of such parties on the Platform and you hereby irrevocably waive any claims against forgood arising from or related to your relationship with another User.
- 3.4 Where you are using the Platform to find volunteers, donations or Offers (including posting volunteer opportunities), your correspondence and relationship with the User/s found on or through the Platform, and any other terms or conditions that apply to such interactions are solely between you and the User/s.

- 3.5 You agree that forgood will not be responsible or liable for any loss, cost, damage, or other liability of any sort incurred as the result of any such dealings, or as the result of the presence of such parties on the Platform and you hereby irrevocably waive any claims against forgood arising from or related to your relationship with a volunteer.
- 3.6 You hereby release forgood, its officers, employees, agents and successors from claims, demands any and all losses, damages, rights, claims, and actions of any kind including, without limitation, personal injuries, death, and property damage, that is either directly or indirectly related to or arises from:
  - a) any interactions with other Users (including volunteer opportunities and Offers), or
  - b) your participation in any activities arising from or related to your use of the Platform.

#### 4. Applicable Restrictions

- 4.1 Access to and use of the Platform is governed by these Terms of Service.
- 4.2 You may not use the Platform for any purpose that is unlawful or prohibited by these Terms of Service, any applicable additional or amended Terms of Service, or any other conditions or notices that are made available on the Platform. Unauthorised use of this Platform may result in forgood instituting a claim for damages against you and/or you may be found guilty of a statutory and/or criminal offense.
- 4.3 By using or accessing the forgood Platform, you undertake to refrain from the following conduct:
  - a) transmitting any worms, viruses, trojan horses, worms, time bombs, or cancelbots and/or other codes or malware of a destructive nature. This includes not interfering with the operation of any of the tools, scripts, routines or codes of the Platform and/or the services, including by using any software, routine or device that will or may interfere with the tools, services and/or website, such as viruses, trojan horses, worms, time bombs, or cancelbots and/or other codes or malware of a destructive nature.
  - b) intercepting any data or personal information of any User or third party transmitted on or via the Platform.

## 7. Your Content

- 7.1 By posting or submitting any content ("Your Content"), (including, without limitation, text, photos, and videos) to the Platform, you represent and warrant:

We reserve the right to remove Your Content if we believe that Your Content violates these Terms or may otherwise cause liability for us.
